NOTICE is hereby given that the 58th Annual General Meeting (AGM) of the Shareholders of the Company will be held on Friday, the 9th August, 2019, at 11.00 A.M. at TTK Auditorium, "The Music Academy", No.168, TTK Road, Chennai 600 014 to transact the business as mentioned in the AGM Notice dated 2nd May,2019.

The Notice of AGM, Proxy cum Attendance slip and the Annual Report for the financial year ended 31st March, 2019 have been mailed/despached to the Members (i) in electronic form to those Members whose e-mail address are registered with Company/ Depositories and (ii) physical copies to all other Members to their address registered with the Company. The Notice of AGM is also available on the website of National Securities Depository Ltd (NSDL) - www.evoting.nsdil.com.

In terms of Section 108 of the Companies Act, 2013 and the rules made thereunder and the provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Company is pleased to provide members facility to exercise their right to vote on resolutions proposed to be considered at the AGM by electronic means which shall be transacted through e-voting services provided by NSDL. Mr. N C Sarabeswaran, Chartered Accountant, has been appointed as the scrutiniser for conducting the e-voting process in a fair & transparent manner.

The remote e-voting period commences on 6th August,2019 (10.00 A.M.) and ends on 8th August,2019, (5.00 P.M.).The remote e-voting module shall be disabled by NSDL for voting thereafter. During the remote e-voting period, members of the Company holding shares either in physical form or in dematerialised form, as on the cut-off date of 2nd August, 2019, may cast their votes electronically. The votes once cast by the members, cannot be changed or cancelled. Any person, who acquires shares of the Company and becomes member of the Company after despatch of the notice and holding shares as on the cut-off date i.e., 2nd August, 2019, may obtain the login ID and password by sending a request at evoting@nsdl.co.in.

The facility for voting through ballot paper shall be made available at the AGM and the members attending the meeting who have not cast their vote by remote e-voting shall be able to exercise their right at the meeting through ballot paper. The members who have cast their vote by remote e-voting prior to the AGM may also attend the AGM, but shall not be entitled to cast their vote again.
