Dear Sir,

I, N C SARABESWARAN, (Membership No: 009861), Senior Partner, Messrs. Jagannathan & Sarabeswaran, Chartered Accountants have been appointed by the Board of Directors of MRF Limited as the Scrutiniser for the purpose of conducting the postal ballot in respect of the Ordinary Resolution/Special Resolutions mentioned in the Notice of Postal Ballot dated 24th February,2023.

I submit my report as under:

- 1. As per the General Circular Nos. 14/2020 dated 8th April, 2020, 17/2020 dated 13th April, 2020, 22/2020 dated 15th June, 2020, 33/2020 dated 28th September, 2020, 39/2020 dated 31st December, 2020, 10/2021, dated 23rd June, 2021, 20/2021 dated 8th December, 2021, 3/2022 dated 5th May, 2022 and 11/2022 dated 28th December, 2022 issued by the Ministry of Corporate Affairs ('MCA Circulars') and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has sent the Postal Ballot Notice dated 24th February,2023 on Tuesday, 28th February,2023 by email only to the members who have registered their e-mail address with the Company / Depositories.
- As per the MCA Circulars physical copies of the Notice, postal ballot forms and prepaid Business Reply Envelopes were not dispatched to Members for this Postal Ballot. Accordingly, the communication of the assent or dissent of the members had taken place through the remote e-voting system only.
- The Members of the Company holding equity shares, as on the "cut-off date" i.e. Friday, 17th February, 2023 were entitled to vote on the proposed resolutions as set out in the Notice of Postal Ballot dated 24th February, 2023, through remote e- voting only.

- 5. The Company has appointed National Securities Depository Limited (NSDL) for facilitating e-voting to enable the Members to cast their votes electronically.
